### **Seminar Description:**

The course will examine the changing perceptions of Israel from 1947 up to date, as seen from the perspective of various Jewish Diasporas. Focusing on the transition between pre- and post-statehood, the students will explore the complex interconnection between the Diaspora concept of Jewish sovereignty and the changing status of Diaspora Jews within their non-Jewish surroundings. While examining these issues through the lens of American Jewry, as the largest Diaspora community, the course will discuss additional Jewish Diasporas, mainly those in Europe and South America.

### **Course Objectives:**

The aim of this course is to acquaint the students with the variety of perspectives of Israel and its role within Diaspora Jewish discourse.

### Method of Teaching:

The seminar is based on the introduction of a variety of primary and secondary texts dealing with Diaspora perspective of Israel and Jewish sovereignty. Throughout the course the students will each be assigned two entries from the reading list, and to present them in class. At the end of the course, students will be required to submit a written paper on Diaspora perception of Israel and of its role within current Jewish discourse. In the Final Paper the students will have to demonstrate their ability to acutely define a relevant research question, to survey the available primary and secondary materials, and to discuss the main questions and issues necessary for the analysis of these texts.
