יעדי ההוראה:

הסמינר עוסק בחקר ההיבטים השונים של רכישת התחביר כשפת אם. בחלקו הראשון של הקורס נתרכז בהסברים שהוצעו במסגרת התאוריה הגנרטיבית להפקת משפטי זיקה והבנתם על ידי ילדים בעלי התפתחות שפתית טיפוסית. לאחר מכן נעמוד על ההבדלים בין רכישה תקינה של משפטי זיקה לרכישתם על ידי ילדים עם לקויות שפה (SLI), ילדים כבדי שמיעה ומבוגרים הסובלים מאפזיית ברוקה (agrammatism, Broca's aphasia)

The seminar deals with certain aspects of the acquisition of syntax in first language. In the first part of the seminar we will focus on the explanations proposed in the Generative framework for the production and comprehension of relative clauses by typically developing children. In the second part we will compare typical acquisition of relative clauses with their acquisition by hearing-impaired children, children with SLI, and individuals with Broca's aphasia.
