## **APPLICATION FOR RESEARCH STIPEND + ACCOMODATION IN THE GRADUATE STUDENT DORMS**

**The present applicant for a research stipend + accommodation in the graduate student dorms hereby declares and undertakes the following:**

*(Please note that the declaration and obligations listed below apply to students of both genders, although for simplicity they will henceforth be worded in the masculine gender alone.) Delete: this cautionary note is not needed in the English version of this document.*

1. I hereby state that I have registered / am registered as a student at Ben-Gurion University of the Negev ("the University").
2. Insofar as I am applying for a stipend that will be paid out to me in monthly payments, I declare and undertake the following:
  - a. I am aware that the requested stipend is intended to enable me to devote all my energy and time to the research so as to help me complete it successfully.
  - b. I am aware that as the recipient of a stipend I am expected to devote most of my time to studies and research and that the scope of my attendance on the University campus will be determined by the department and my supervisor in line with what is required to enable the research to progress at the appropriate pace
  - c. I am aware that any interruption of my studies at the University before their completion for whatever reason, including due to failure to fulfill my academic obligations whether fully or partially, or inappropriate behavior, will lead to termination of the stipend payments.
  - d. I undertake to inform the Dean of Students of any change in my academic status immediately and no later than a week from such a change taking place.
  - e. I am aware that if I am allowed to continue to live in the graduate dorms after termination of the stipend, I will be liable for the full fee without any deduction for the stipend.
  - f. I hereby agree that the operator of the graduate student dorm at the University will be given a copy of this application, as well as any information relating to my stipend application, and/or to the sums paid out to me as a stipend, and/or any other detail relating to the stipend and to my right to live in the graduate dorms, and I waive the right to any complaint or legal claim in regard to the communication of the said information, whether under the Protection of Privacy Law – 1981, or any other statute.

g. I hereby agree to assist the University as needed to mobilize financial contributions to finance the stipend, including by writing a letter expressing my gratitude to the donor if required. I authorize the University to communicate details regarding the stipend and my studies as part of its efforts to raise donations, and I waive the right to any complaint or legal claim regarding the transfer of this information, whether under the Protection of Privacy Law – 1981, or any other statute.

h. I am aware that, should it emerge that I gave the University erroneous details or failed to report any change in substantive details communicated by me to the University, I will have to return to the University all the sums I received as a stipend and I will be barred from submitting additional and/or different stipend applications, without prejudicing the right of the University to take whatever disciplinary steps against me that it may deem necessary.

i. I hereby agree that insofar as I become indebted to the University, whether due to payment to me of excessive sums or payments in contravention of regulations, I will be required to return this debt, and I hereby authorize collection of this debt as part of my tuition fee, in accordance with the rules and collection mechanisms customary at the University regarding tuition fee debts.

j. I am aware that the stipend is tax-exempt insofar as it meets the income tax authorities' criteria in this regard. Furthermore, I am aware that the tax liability is personal and that I am liable as recipient of the stipend.

k. I am aware that insofar as I receive a stipend, it is not in payment for work and does not constitute an employee/employer relationship, nor does it entitle me to workers' rights of any kind.

I have read and understood the guidelines and rules governing the granting of stipends to graduate students and their employment, as detailed in:

I am aware that these rules also apply to the housing stipend that is the object of this application and that I am obligated to inform myself of any changes that may occur from time to time, and I undertake to abide by them.
