David Ben-Gurion's Leadership as a "Two-Way Interaction Process"

An Archive Based Workshop for Graduate Students

Course Description:

The persona, influence, and Modi operandi of Israel's first PM, David Ben-Gurion, have been central in studies on the history of Israel. Relatively few studies, however, focus on the patterns of Ben-Gurion's leadership in an attempt to decode his personality and the sources of his influence. This course seeks a better understanding about one pattern in Ben-Gurion's leadership—his communication with "the public" or, to be more precise, with his followers. Using Ben-Gurion as a case study, a model is proposed that applies current leadership theories that view the leadership phenomenon as "a relationship that is jointly produced by leaders and followers."

The course proposes an analysis of Ben-Gurion's leadership through the conceptualization of leader–follower interrelations, following Sheer's paradigm of leadership as a "two-way interaction process. The course will follows BGs <u>decision making</u> and <u>policies</u> throughout the history of Israel using the BG archives as a learning tool and offering students an opportunity of research and discovery

Course Objectives:

- A preliminary encounter with Leadership-Followership theories and historical studies
- Covering BGs Public Biography since the establishment of Israel and throughout his PM years and post PM years
- Tracking down and analyzing historical records.
- Experiencing research as a learning process uncovering historical episodes through archive items

Course Structure:

Following chronological and thematic outline of BGs Biography – classes will lean on historical records

Teaching Method:

The course is designed as a workshop and each meeting will include team research in small study groups and class discussions following them. Students will be required to complete reading before Each class (according to the syllabus). All readings are available on the course website. In addition to these readings, primary sources will be tracked, presented, and discussed during class meetings. See below the full reading list.
