Course Description:

In this course we read and discuss important sociological and anthropological studies that are highly relevant for understanding Middle Eastern societies past and present. Some of these studies directly deal with Middle Eastern cultures while others emerge from various historical contexts outside the Middle East. Together, we will examine the methods, the theories and the problems of major sociological and anthropological works and their contribution to our understanding of the Middle East.

Course Objectives:

The main aim of the course is to provide the necessary theoretical foundations in the field of anthropology for the purpose of interpreting Middle Eastern cultures and societies. Another principal objective of this course is to gain experience in critically reading canonical texts – revealing their premises, studying their weak spots and examining their contribution to our understanding of the cultures of our region.

Course Structure:

The course is divided into 26 meetings. In most of the course meetings there will be a discussion of one major study (+ further reading), based on individual reading.

Teaching Method:

The course will be based on individual reading at home and group discussion in class. The students should prepare their weekly assigned readings and come to class with significant questions that stem from the readings. Every student will present two or three studies (Further Reading) in the classroom according to the list of presentations.

Structure of Final Grade:

Course grade will be based on class attendance, individual presentations, knowledge of readings and active participation (75%), and on a final paper, which will review a major sociological or anthropological work that is relevant to the understanding of the modern Middle East (25%).
