## **Seminar Description:**

The course will examine the main characteristics of the Jewish communities in the Middle East and North Africa in the 20<sup>th</sup> century. It will focus on the changes as a consequence of European colonialism, the rise of Arab Nationalism and the emergence of Zionism in the middle East. The course will also deal with the emigration from Arab countries and the integration in Israel.

#### **Course Objectives:**

Jewish history usually deals with European history. The aim of this course is to acquaint the students with another history – that of the Jews who came from Islamic countries, Jews who constitute a half of the Jewish population in Israel.

#### **Method of Teaching:**

The seminar is based on reading and analyzing documents and articles.

Throughout the course the students will have to study the background for each document, to read the relevant articles and to present two of them in class.

At the end of the course, students will be required to submit a written paper about one of the topics of the course.
