· Synopsis of research

My research focuses on various issues within the sociology of tourism, including tourist typologies, the tourist experience, guest-host interaction and late/post-modernity. Another stream of research addresses issues of tourism management, such as consumer (risk) behavior, sustainable tourism development, and public policy. My academic work, alone and with colleagues, consists of both theoretical conceptualizations and empirical studies. The latter are mostly based on qualitative methods but include surveys and quantitative analyses as well.

The issue of the tourist experience receives a major attention in my work and could be seen as the core of my research agenda. For example, the two most cited papers that I wrote are entitled "The Backpacking Experience" (Uriely, Yonay and simchai, 2000) and "The Tourist Experience" (Uriely, 2005). The former presents a new analytical tool that distinguishes between *types* and *forms* of tourism in order to stress the variety of backpacking experiences. The "tourist experience" conceptual paper points towards the increasing impact of postmodern theories on studies about the tourist experience. The attention given to tourists' subjective experiences is also evident in other contexts, including tourists' drugs consumption (Uriely and Belhassen, 2005, 2006) tourists' exposure to terror (Uriely, Maoz and Reichel, 2007, 2009), tourists' sexual behavior (Berdichevsky, Poria and Uriely, 2010) and the visiting friends and relatives (VFR) category of tourism (Uriely, 2010).

Most of the above studies stress the importance of situations in shaping tourists' behaviors and subjective experiences. The situational approach is even more salient in my studies about encounters and interactions between tourists and locals (Uriely and Reichel, 2000; Pizam, Uriely and Reichel, 2000; Uriely, Maoz and Reichel, 2009; Uriely, 2010). Based on micro-sociological perspectives, including symbolic interaction, exchange theories and social psychology, these studies examine the nature of the guest-host contact and its result in terms of attitudes change. While my earlier guest-host studies were focused mainly on the perspective of the tourists, my recent

research in this area focuses on the perspective of local hosts as well. The "host gaze" is explored in the study about Israeli tourists and Egyptian service providers in Sinai (Uriely, Maoz and Reihel, 2009) as well as in my recently accepted paper on hosting friends and relatives (Shani and Uriely 2011).

The issue of risk in tourism is also included in my research agenda. Some of the aforementioned studies on tourists' drugs consumption (Uriely and Belhassen, 2006) and tourists' exposure to terror (Uriely, Maoz and Reichel, 2007) are focused around the issue of voluntary risk-taking. These studies reveal the tourists' rational of engaging in risky activities and stress the notion of their "controlled de-control" behavior. In other words, these studies challenge the earlier depiction of theses risk-taking tourists as unrestrained action seekers. A different direction of risk-related studies concerns the issue of tourists' risk perceptions mainly from the marketing perspective of consumer behavior (Reichel Fuchs and Uriely, 2007, 2009). A recent study in this line of research (currently under review) attempts to examine the relationships between tourists' risk perceptions and tourists' sensation seeking (Uriely, Fuchs and Reichel 2011).

As indicated in the above list of publications, I am also a coauthor of one book and two papers on tourism law in Israel (Meydani and Uriely, 2006, 2007, 2008). These publications derived from a research project granted by the Israeli Ministry of Tourism. The main goal of this project was to provide scholars and practitioners with systematic information about hospitality and tourism-related laws in Israel. However, the book and the two papers also deal with issues of public policy and the politics of tourism laws in Israel. Another research project that was sponsored by the Israeli Ministry of tourism evaluated the potential of tourist attractions in the Israeli Negev region. The papers derived from this project present an integrative model for sustainable tourism development in desert areas (Uriely, Reichel and Shani, 2007; Reichel, Uriely and Shani, 2008). The attention given to environmental issues in this project is also manifested in two other papers on "eco-leisure" activities (Uriely and Ron, 2004; Shani, Ron and Uriely, 2008).

The recent publication entitled "Psychoanalytic Sociology of Deviant Tourist Behavior" (Uriely, Ram and Malach-Pines, 2011) exemplifies my current inclination to conduct interdisciplinary research that combines sociological with psychological perspectives. I believe that such an approach, which considers both the social settings of the situation and internal processes within the individual, is required for further understanding of tourists' behaviors and experiences. Accordingly, the interdisciplinary approach that combines sociology with psychology is also implemented in the "research in-progress" about familial vacations (with Y. Ram and A. Malach-Pines). Note that this project is also granted by the Israeli Ministry of Tourism.

I believe that the interdisciplinary nature of my research and the inclination to address various issues within the areas of tourism and leisure would characterize my future research as well. However, it seems that my main interest in tourists' subjective experiences will be still evident in both my near future empirical research and my attempts to introduce the study field of tourism with theoretical developments.
