# Course Objectives

The study of the European Union's (EU) relations with the Middle East is of a particular interest mainly because it reflects what has been faced by the EU in gradually establishing the Union's position in external relations and its foreign policy mechanism.

The Middle East was on the agenda of the first meeting of the European Political Cooperation (EPC) and has remained there ever since. The Union's behaviour vis-à-vis the conflicts in the Middle East and in the Mediterranean reflects to a large degree the conditions under which the EU developed its actorness. In light of this, the course serves as an analysis of the EU as an international actor, as well as an analysis, of the Union's relations to the Middle East.

The course analyses the relationships between the EU, the Middle East from the early 1950s to the present day in three parts: the first part of the course discusses the EU as an international actor in the Middle East. The second part of the course analyses the

developments in the European-Middle Eastern relations between 1950 and 1991. This part of the course focuses on relations between 1950 and 1969, EC/EU-Middle East relations between 1969 and 1991. The course then deals with the EU-Middle East/Mediterranean relations between 1991 and present day. The third part of the course reflects on some of the most central issues and challenges facing the EU and the Middle East today.

#### Requirements

- 1) Oral presentation and podcast: 10%
- 2) Research paper: 90% (40% for students participating in the concluding debate; the paper is due on August 31, 2022, 12:00PM.

CLASS PARTICIPATION REQUIREMENTS: Readings have to be done prior to class in order to be able to participate in discussions and arguments. Students should listen to their fellows' arguments and discussions and be able to engage with them is constructive discussions. Attendance in class is mandatory and crucial for doing well in this course.

ORAL PRESENTATION: Starting from November 10, 2022, students are required to make a presentation (about 20 minutes) on a theme of their choice, relevant to the course topics (to be approved by and co-ordinated with the course instructor). Following the inclass comments and discussions students are required to record these presentations in a podcast format to uploaded to the course's Moodle website.

MENT.IO DISCUSSIONS: Ment.io provides an AI-discussion platform for engaging students in hybrid classrooms. A modern look discussion board, providing valuable structure and encourages a meaningful, more collaborative discussion. Students are required to participate in all Ment.io discussions.

RESEARCH PAPER: The research paper (3,000 words; on a theme to be approved by and co-ordinated with the course instructor) is due on August 31, 2022, 12:00PM.
