תיאור הקורס
תקציר בעברית:

הקורס בוחן את מערכת היחסים של האיחוד האירופי, רוסיה והמדינות האירופאיות החדשות שהוקמה עם התפרקותה של ברה"מ (עם הדגש על המדינות הבלטיות, אוקראינה, גאורגיה, מולדובה ובלארוס). נציין שלוש תקופות בהתפתחות והמשגה של יחסים בין רוסיה והאיחוד האירופי: (1) "שותפות ושיתוף פעולה" (2) "שיתוף פעולה אסטרטגי" הנקבע בהתאם לנוסחה של "מרחבים משותפים" (3) החרפת הקרע. נתייחס לקונטקסט הביתי והבינלאומי של רוסיה ושכנותיה על מנת להסביר את הכישלון של האיחוד האירופי להשיג את מטרתו האסטרטגית – לייסד דמוקרטיה יציבה ברוסיה ובמדינות הפוסט-סובייטיות.

The course examines the relationship of the EU, Russia and the European countries that emerged from the breakup of the USSR. We indicate three periods in the development and conceptualization of relations between Russia and the European Union: (1) 'Partnership and Cooperation'; (2) 'strategic cooperation' regulated by the 'Common spaces' formula; (3) growing rift. We'll explore the domestic and international contexts of Russia and the post –Soviet states
